A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COSTA MESA, CALIFORNIA, SUPPORTING THE INCLUSION OF THE EXTENSION OF STATE ROUTE 57, ORANGE FREEWAY, FROM ITS CURRENT TERMINUS SOUTHERLY TO I-405 FREEWAY AS AN ALTERNATIVE FOR THE CENTRAL COUNTY CORRIDOR MAJOR INVESTMENT STUDY.

THE CITY COUNCIL OF THE CITY OF COSTA MESA HEREBY RESOLVES AS FOLLOWS:

WHEREAS, State Route 57, Orange Freeway, is currently a major component of the Orange County freeway network that is heavily used by commuters who rely on it for north-south travel; and

WHEREAS, if extended through its current terminus to intersect Interstate 405, the Orange Freeway would relieve pressure from the already congested State Route 55 and several local arterials and highways; and

WHEREAS, the Orange County Transportation Authority has initiated the Central County Corridor Major Investment Study to define and analyze various improvement alternatives in the Central County area; and

WHEREAS, the Orange County Transportation Authority is considering among others, an alternative that considers the extension of the State Route 57, Orange Freeway along the Santa Ana River Corridor as part of the Central County Corridor Study Major Investment Study;

NOW, THEREFORE, BE IT RESOLVED that the City of Costa Mesa supports the inclusion of extension of State Route 57 along the Santa Ana River from its current

southerly terminus to the I-405 Freeway as one of the alternatives in the Central County Corridor Major Investment Study.

BE IT FURTHER RESOLVED that the City of Costa Mesa opposes any consideration or study or extension of the State Route 57 along the Santa Ana River, or along any other similar alignment, south of the I-405 Freeway; and

BE IT FURTHER RESOLVED that the City of Costa Mesa opposes any impacts from the connectors between the SR-57 and I-405 Freeways to residential areas south of I-405 Freeway.
