RECOMMENDATION:

That the City Council decides whether they wish to support the Veterans' Memorial proposed by Bud Hohl and if so, specify what type and level of support.

BACKGROUND:

Bud Hohl, President of the Costa Mesa Chapter of the Veterans of Foreign Wars, has requested that the City of Costa Mesa lend support to a proposed Veterans' Memorial to be constructed at Harbor Lawn Memorial Cemetery in Costa Mesa. The estimated cost for construction of the memorial is \$131,392.00.

ANALYSIS:

For some time, Mr. Hohl has been working on a concept for a memorial to recognize veterans of World Wars I and II, the Korean War, the Vietnam War and the wars in Iraq who are buried at Harbor Lawn Memorial Cemetery. Mr. Hohl's brother, himself a veteran, had drawn up initial designs for the monument (see Attachment 1). However, subsequent to this, Mr. Hohl found and purchased a bronze cast eagle that he now wishes to be the focal point of the monument (see Attachment 2). The eagle is six feet tall, six feet wide and four feet in depth. Given this, the originally designed pediment would not be large enough to hold and anchor the eagle. The proposed design has changed accordingly. It is now envisioned that the eagle will stand on a cement or concrete pad and be framed by a six-sided wall. One of each of five panels will be dedicated to a branch of the service, with the center panel containing information on the monument itself (date of dedication, names of those involved in its construction, etc.).

Rose Hills, the company that owns and operates the cemetery, has agreed to the placement of the memorial on the cemetery grounds (see Attachment 3). The monument will be constructed where a small memorial, consisting of a World War II artillery gun on a concrete pad and a surrounding walkway, now stands. The memorial eagle, purchased by Mr. Hohl, is currently being stored on the cemetery grounds.

A small committee comprised of Fire Chief Jim Ellis, Legislative and Public Affairs Manager Ann Shultz and Fire Fighter/Paramedic Henry Santo have met with Mr. Hohl to discuss his concept. In addition, Fire Fighter Santo has obtained quotes on different

elements of the project from local general contractors. The figure of \$131,392.00 is based on very rough estimates from these contractors and includes the pad, walkway, Stand and memorial wall. The attached chart (see Attachment 4) shows a breakdown of the estimates.

The obvious impediment to the construction of the memorial is funding. Mr. Hohl has no financing for the project. He has met with the Board of the Costa Mesa Community Foundation. Although they support the concept, they do not currently have any funding available to contribute to the project. Staff has also checked on possible state and federal funds and grants and found that there are currently no funds available through these sources.

If the Council approves the memorial concept, funding would have to be solicited from such possible donors as veterans' groups, Costa Mesa based businesses and service organizations and individuals. The money could be received and collected through the Costa Mesa Community Foundation.

CONCLUSION:

The City Council must decide whether they wish to support Mr. Hohl in this effort and if so, specify what the level of support and involvement is to be.


