

RESOLUTION NO. 06 - _____

A RESOLUTION OF THE CITY COUNCIL OF THE CITY
OF COSTA MESA, CALIFORNIA, ESTABLISHING A
FIREWORKS "CLEAN-UP" FEE FOR FIREWORK SALES.

THE CITY COUNCIL OF THE CITY OF COSTA MESA DOES HEREBY
RESOLVE AS FOLLOWS:

WHEREAS, the City Council has complied with the notice and hearing procedures
set forth in Government Code Section 66016 et. seq.; and

WHEREAS, the City has annually incurred additional costs for cleaning City
streets, public right-of-way, City parks, and open space after the conclusion of the fourth
of July celebration; and

WHEREAS, the City Council desires to establish a fee to be spread amongst
fireworks stand permit holders annually to reimburse the City for the additional clean-up
costs incurred each year; and

WHEREAS, the additional "clean-up" costs incurred by the City for cleaning City
streets, public right-of-way, City parks, and open space after the 2005 Fourth of July
celebration have been estimated at \$3,147.23; and

WHEREAS, the total number of fireworks stand permits issued during the 2005
Fourth of July celebration amounted to twenty-eight.

NOW, THEREFORE, BE IT RESOLVED as follows:

Section 1. The Permit Fee for obtaining a fireworks stand permit is hereby set at
\$265.00 per application to be paid at the time the application is filed.

Section 2. The Fireworks "Clean-up" Fee, required of all persons obtaining a fireworks stand permit, is hereby set at \$100.00 per application, to be paid at the time the application is filed. The Fireworks "Clean-up" Fee shall be refunded to any applicant who does not receive a fireworks stand permit.

Section 3. The Permit Fee for fireworks stands and the Fireworks Clean-up Fee are hereby incorporated in and shall become a part of, the City's Annual Fee Resolution and shall, subsequently be reviewed and updated at the same time, place and manner as the City's other rates, fees and charges.

Section 4. The City Clerk shall certify to the adoption of the Resolution.
