On 01-16-06 at 1410 hours, I responded to 660 W. 17th St., Urbanism Furniture, reference two juveniles vandalizing a wall with spray paint. CMPD Communications was on the phone with the reporting person, Melissa Perrin. Perrin told CMPD Communications that she had followed the two juveniles to the 510 W. 17th St., "Michaels" crafts store. Perrin described one of the juveniles as a male with orange hair. The other juvenile was a male wearing a black beanie, black shirt, and blue jean shorts. Perrin was standing outside of the store with the juvenile with orange hair. The other juvenile walked away towards Del Taco, located on the corner of 17th St. and Superior Ave.

Prior to arriving at 510 W. 17th St., I patrol checked the Del Taco premises but was unable to locate any juveniles. I proceeded to 510 W. 17th St., to meet with the Perrin and the second juvenile. Upon my arrival, Park Ranger Pallo was on scene with Pimental and the juvenile. Officer Pallo told me the following.

Pallo arrived and saw Perrin and her fellow employee, Brooke Pimental, talking to the juvenile with the orange hair, outside of "Michaels". The juvenile was sitting on the ground next to two bikes. The juvenile was on his cell phone, refusing to get off the phone and speak with Pallo.

I separately spoke with Perrin and Pimental who told me the following. On 01-16-06 at approximately 1410 Hours, Pimental and Perrin were working inside at 660 W. 17th St., Urbanism Furniture. Sylvia Bay, the store manager, suddenly yelled, "those guys on bikes just sprayed our wall". Perrin and Pimental both looked at saw Bay pointing out the window at two juveniles on bicycles. Both juveniles slowly rode away on their bicycle towards "Michaels". They were unaware that they had been seen spray painting the wall. Perrin and Pimental followed the juveniles to "Michaels".

Both juveniles parked their bikes outside of "Michaels". The juvenile with the black hat went inside while the other juvenile (later identified as [REDACTED]) wait outside with the bikes. Perrin called the police while Pimental talked with [REDACTED] about his bike. The other juvenile came out of the store and saw [REDACTED] being questioned by Perrin and Pimental. He then walked across the street towards Del Taco, out of Perrin's and Pimental's site. Refer to Perrin's and Pimental's written Citizens Statement for more information.

Sylvia Bay arrived on scene and told me the following. Bay is the store manager for Urbanism Furniture. On 01-16-06 at 1410 hours, Bay looked out her window and saw two juveniles spray painting the north wall adjacent to the business. Bay yelled, "those guys on bikes just sprayed our wall", and her two employees ran after them.

Bay identified [REDACTED] as one of the two juveniles who spray-painted the wall. Bay told me that [REDACTED] was the juvenile who was holding the spray can and who painted the wall. Bay saw the bikes next to [REDACTED] and told me, "I specifically recognize that Turquoise bike. That is the one he was riding". Refer to Bay's written Citizen Statement for more information.

Bay requested to make a citizens arrest on [REDACTED] for PC 594(a). Bay signed a Citizens Arrest Form. Bay desired prosecution.

I accepted the Citizen's Arrest on [REDACTED]

Officer Paulo requested CSI to take photographs of the wall and stood by until CSI arrived. Refer to the CSI report for more information.

I handcuffed [REDACTED] with his hands behind his back and double locked the handcuffs. I transported [REDACTED] to CMPD for booking and fingerprints.

At the CMPD I was informed that CSI found the spray can that was used to spray paint the wall at 660 W. 17th St. and fingerprints were lifted from the can.

At CMPD, I read [REDACTED] his Miranda rights from my Miranda Rights Warning Card. [REDACTED] answered, "yes" to understanding each statement.

[REDACTED] told me the following. [REDACTED] denies doing the spray painting, but admits that his fingerprints are on the can. [REDACTED] said he did hold the can. [REDACTED] refused to give the name of his friend that was with him. [REDACTED] said his friend does a lot spray painting in the area.

I asked [REDACTED] what did they spray paint on the wall. [REDACTED] told me "Amid One". [REDACTED] denied knowing what that stood for and said his friend likes to write that.

[REDACTED] was photographed and fingerprinted at the CMPD.

[REDACTED] was later released to the custody of his mother.

Per Bay's Citizen's Arrest, I request that this report be forwarded to the District Attorney for further review.
