

Consent Calendar Item #6 - Award of a contract for Conceptual Design and Public Outreach to KFM Engineering for a multi-purpose trail at the Paularino and Santa Ana Delhi Flood Control channels

Decision by: City Council

Reasons for requesting review, appeal or rehearing: 1) The item before the City Council was the award of a contract to advance a project previously approved by the City Council. The action taken - "Not to move forward with the contract at this time" effectively stops all progress on this project. 2) Because the item was a contract award, no notice was given to the residents of Mesa del Mar or other residents interested in establishing more multi-purpose trails. While the City Council has previously received many letters of support for the project, those letters were not made available for this item. 3) The proposed contract was for both public outreach and preliminary design for this project. The concerns expressed by residents at the December 4, 2007 meeting could have been addressed if the public outreach effort had been approved. Given the action taken, no progress will be made in addressing either existing concerns or how the proposed project could reduce/eliminate those concerns. 4) If the City Council's concern is a commitment to construct the project before the public outreach effort is complete, staff can renegotiate the contract to insure public concerns are identified well in advance of any detail design. If desired, the City Council may want to direct that following the initial public outreach effort and preliminary design, the matter be brought before the Parks & Recreation Commission for hearing before any final conceptual design.
