

RESOLUTION NO. 08-___

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COSTA MESA, CALIFORNIA, REVISING THE PAY RANGES FOR JOB CLASSIFICATIONS REPRESENTED BY THE COSTA MESA POLICE ASSOCIATION (CMPA) PURSUANT TO THE 2007-2010 MOU.

The City Council of the City of Costa Mesa does hereby resolve, determine and order as follows:

SECTION 1. The following pay ranges and monthly rates of pay for the identified job classifications are hereby established and placed under the Basic Pay Schedule for Sworn Police Officers effective August 31, 2008. The monthly rate of pay may also be in increments between the monthly minimum and maximum pay step. In addition, the City pays the employees' nine percent (9%) retirement contribution to the California Public Employees' Retirement System (CalPERS).

SECTION 2. A.B.L.E. (Airborne Law Enforcement) Bureau Commander Assignment: The A.B.L.E. Bureau Commander is an assignment specific position in the A.B.L.E. organization, with no commensurate position within the Costa Mesa Police Department. The A.B.L.E. Bureau Commander position is subject to assignment by the A.B.L.E. Board of Governors and may consist of either Costa Mesa or Newport Beach Police personnel (assigned to A.B.L.E.) based upon the needs of A.B.L.E. Any Costa

Mesa Police Helicopter Sergeant assigned to the position of A.B.L.E. Bureau Commander shall receive "Move up" compensation only for the period in which he/she serves in that capacity.

SECTION 3. All parts of resolutions in conflict herewith are hereby rescinded.
