

**SERVICE AGREEMENT BETWEEN HEWLETT-PACKARD COMPANY (“HP”) AND CITY OF COSTA MESA (“CUSTOMER”),
EFFECTIVE February 1, 2009**

THEREFORE, in consideration of the promises and mutual agreements reflected in this document and in its attachments, HP and Customer hereby agree as follows:

Each portion of the Agreement/Purchase Order, designated respectively as HP Reference Numbers 42498807,42498813, 42499231, 42383751, 4249923, 42499234, 42499236, and 42499237 shall be subject to the terms and conditions set forth in Contract #SVC00183-CS (HP Terms and Conditions of Sales and Service), the latter as modified by agreement of the parties and reflected in Attachment ___ hereof.
