RECOMMENDATION:

Adopt resolution (Attachment 1) designating the event route and street closures for the 2009 Orange County Marathon.

BACKGROUND:

The City Council, at their meeting of January 20, 2009, approved a request by organizers of the 2009 Orange County Marathon for the use of certain streets in Costa Mesa to conduct a full marathon, half marathon, and 5K fun run on May 3, 2009. A copy of the staff report is attached (Attachment 2). The streets along the marathon route will require either a partial closure or full closure.

ANALYSIS:

In accordance with Costa Mesa Municipal Code, Section 9-208.9, a City council resolution is required to establish pre-designated event routes that require full or partial street closures.

Three distinct areas of the City have been pre-designated as event routes for street closures. These areas are shown on Attachment 3. The route approved for the 2009 Orange County Marathon is not included in the pre-designated special event areas; therefore, adoption of a resolution is necessary to designate the specific routes and street closures for the full marathon, half marathon, and 5K fun run events.

ALTERNATIVES CONSIDERED:

An alternative is to not adopt the resolution, thereby not designating the route and street closures for the event. However, this action is not in accordance with the earlier City Council recommendation.

FISCAL REVIEW:

There is no fiscal impact to the City directly related to this item. The City will be reimbursed for the actual cost of services required to conduct the street closures for the 2009 Orange County Marathon pursuant to a Police Department Special Services Contract.

LEGAL REVIEW:

The office of the City Attorney has reviewed and approved the attached resolution as to form and content.

CONCLUSION:

A resolution has been prepared to designate the specific routes and street closures for the 2009 Orange County Marathon events, as approved by City Council at their meeting of January 20, 2009. Adoption of the resolution designating the event routes is recommended in compliance with Costa Mesa Municipal Code, Section 9-208.9.
