Balance of traffic approach volumes is one of the most important considerations in establishing multi-way stop control. A multi-way stop control may be considered warranted if 1, 2, or 3 below are met and the approach volume balance is 60/40 or better for major street vs. minor street respectively. If a severe accident or delay problem exists, intersections farther out of balance may be considered on an individual basis.

A. Where traffic control signals are justified, the multi-way stop is an interim measure that can be installed quickly to control traffic while arrangements are being made for the installation of the traffic control signal.

B. An accident problem, as indicated by 5 or more reported accidents in a 12-month period that are susceptible to correction by a multi-way stop installation. Such accidents include right- and left-turn collisions as well as right angle collisions.

C. Minimum volumes:

1. The vehicular volume entering the intersection from the major street approaches (total of both approaches) averages **at least 300** vehicles per hour for any 8 hours of an average day, and; (Average vehicular volume/hour 227)
2. The combined vehicular, pedestrian, and bicycle volume entering the intersection from the minor street approaches (total of both approaches) averages **at least 200** units per hour for the same 8 hours, with an average delay to minor-street vehicular traffic of at least 30 seconds per vehicle during the highest hour.

3. If the 85-percentile approach speed of the major street traffic exceeds 40 miles per hour, the minimum vehicular volume warrant is 70 percent of the above requirements (C.1 and C.2).
