My wife, Trudy, and I have been homeowners in Costa Mesa for over 40 years. We raised our daughter here and she graduated from Estancia High School. We feel fortunate that the City employees are dedicated professional individuals and they make our City work and keep us safe. We also feel fortunate that the City has high quality commercial development that provides extra support in covering the City's costs.

I would like to serve on the Charter Committee to help the City find a way to reduce its operating costs so that a larger portion of General Fund revenue is available to make important physical improvements to the City, provide important services to the community, and increase the City's reserve fund to protect against significant negative events (major disaster, recession, etc.) and allow the City to take advantage of opportunities that may arise (sale of the Fair Grounds, etc.). Also, I would like to help the City find a way to prevent a future unfunded liability from occurring, particularly one similar to the significant unfunded pension and medical benefits liability (\$250 million to \$450 million) the City now has. I would like to serve on this committee as I feel this is one of the most important decisions facing our city governance which will impact all the citizens in Costa Mesa. I feel it is a critical piece that can shape governance for our city in positive ways. The Charter that was put forth to the voters in the last election was defeated. I believe it was defeated primarily because many citizens didn't fully understand all that was contained in the Charter, the impacts the Charter would have, and many felt it did not include enough community input. I would like to serve on the Charter Committee to help determine Costa Mesa's future. I will make as much time available as needed to research, understand, and help develop a framework for the City's future governance.

The City is controlled by financial realities while it tries to promote rational growth and improvement. My experience as a business owner and as a member of both high-level military and corporation staffs helps me understand the limits of theory in reaching goals. Getting a job done requires planning and control, certainly, but it also involves compromise and negotiation. Both need to be available to future City Councils under any charter that is adopted. A minor in accounting and college training in systems design will help me identify and understand consequences of what we write into the charter.

The City will best serve the citizens, in my opinion, when its direction reflects the will of those citizens. So, any charter that is adopted should insure that citizen guidance can be collected and considered in conducting City business. I believe that the charter should continue the transparency begun in Costa Mesa with our COIN ordinance.

I'm aware that City government is unique in management systems; using business as a model can be useful, but it's important to remember that the model is not the system. I worked in Federal Civil Service for over ten years. The experience taught me that there're a lot of ways to get a job done, and many groups that are sure that their way is the best way. - I have been involved in many large committees with a variety of participants including business owners, lawyers, academicians, and lay persons interested and involved in the subject matter. In that role I have learned how to facilitate and/or participate in the committee environment, and how to deal and interact with all kinds of committee members that have specific agendas. Believe me, I understand the challenges that confront the Charter Committee.

However, I believe the most important qualification I bring to the Charter Committee is an Open Mind. I heard so much confusing talk and misinformation last fall about the pros and cons of the Charter that I really have no clear vision of what a good charter is and what it could do for our City. Because of this, I have no preconceived ideas and am definitely not biased either pro or con. I guarantee to bring an open mind and a spirit of cooperation to the committee, and will work towards providing the citizens of Costa Mesa the best product the Charter Committee can produce.
