To the City of Costa Mesa Planning Staff / Commission

RE: Application PA-11-02 for a Recycling Facility @ 2025 Placentia Ave

I own the single family home at 2014 Federal Avenue that backs up to the side of the proposed development. After looking over the proposed design and talking with the family with a newborn that lease the property, I am concerned about three issues regarding this project:

1. While the existing property directly behind 2014 Federal currently has commercial/industrial buildings with parking in the rear. It does not see a steady 7 am to 7 pm flow of traffic. This proposed use will, by virtue of a shared egress driveway, increase the auto and truck noise/fumes 100 fold. This plan brings the retail traffic all the way to the rear of the property up to our backyards. Typically the rear area next to residential would be designed as a buffer limited to deliveries and employee parking, with the concentrated retail traffic centered on Placentia.
2. Since our property is not directly behind the rear of the proposed Development and directly behind the project there is a storage building proposed. We will actually be more adversely impacted than the house directly behind. I am concerned that the existing wall behind our property may not screen the proposed recycling structures or the noise and fumes generated. Can there be a mandated condition of approval if this project moves forward that the wall height needs to fully screen the project development from the rear residences, and be rebuilt at the developer's expense if needed?
3. I know that the proposed design calls for a completely enclosed facility with a sound insulated design. Is there a Decibel threshold that they expect to remain below? Is there any mandated maximum they are required to stay within? What happens if they exceed that number? Would they be shut down or only cited?

Of course I am concerned that this facility renders the adjacent residential properties uninhabitable or at the least the residents not able to enjoy/use their backyards. Whether from constant 7 AM to 7 PM Mon-Sat operations noise or odors this could, if not mitigated, effect the ability to rent and or sell the property in the future. If this project is approved, we would want to see the operating hours limited to 8 AM to 5 PM Mon- Fri and very limited 10 AM to 2 PM Sat. to minimize the impacts. Thank you for your consideration.
