Description: The proposed project involves the following:

1. Adoption of an Initial Study/Mitigated Negative Declaration (IS/MND);
2. Rezone R-15-01 for the rezone of a 3.2-acre site from PDC (Planned Development Commercial) to C2 (General Business District).
3. Conditional Use Permit PA-15-30 for the demolition of the existing automotive strip mall (Bristol Autoplex) and the development of a two-story, 774-unit mini-storage facility and 5,000 square foot food court building. No code deviations are requested.

Environmental Determination: An IS/MND was prepared for the project in accordance with the Lead Agency's Guidelines implementing the California Environmental Quality Act. The IS/MND is available for public review and comment from May 14, 2016 to June 12, 2016. The IS/MND and supporting documents are available for review during normal business hours at the following locations: (a) City of Costa Mesa, Public Counter, 77 Fair Drive, Costa Mesa, CA, (b) Mesa Verde Library, 2969 Mesa Verde Drive, East, (c) Costa Mesa/Donald Dungan Library, 1855 Park Avenue, and can be viewed on the City's webpage www.costamesaca.gov under the Development Services Department/Planning Division heading for environmental documents. The IS/MND found that the environmental effects from the project would be less than significant with the incorporation of standard conditions of approval and compliance with the Code requirements. The proposed project site is not on a list compiled pursuant to Government Code Section 65962.5

Public comments in either oral or written form may be presented during the public hearing. If the public wishes to submit written comments to the Planning Commission at the hearing 10-copies will be needed for distribution to the Commissioners, City Attorney and Staff. If you challenge this action in court, you may be limited to raising only those issues you, or someone else raised, at or prior to the hearing.
