

SUBMISSION GUIDELINES

- ▶ Artists must reside in the Southern California area.
- ▶ Artists may submit up to three pieces of ORIGINAL artwork for this juried show that were not exhibited in previous ARTventures. Reproductions & giclée will not be accepted.
- ▶ Two-dimensional artwork may not be smaller than 8"x10". The artwork, including the frame, may not exceed 42" in width or height, and shall not exceed 25lbs in weight. Hanging wire will be required to secure artwork to hanging system. An unblemished black or dark brown frame is highly recommended.
- ▶ Standing sculptures may not exceed 40" in width, depth or height and shall not exceed 100lbs in weight. Floor stands must be provided with all sculptures.
- ▶ For artists 17 and under, application must be submitted by a parent or guardian.

SUBMISSION REQUIREMENTS

1. Completed Artist Application
2. Artwork Images - Digital files or hard copies will be accepted. Clearly label images (file or hard copy) with artist's name (last, first) and title. Digital images must be submitted as a high-quality JPEG (minimum size 1024x768 pixel) or a PDF. Hard copy images must be submitted on a 8.5" x 11" piece of paper.
3. Resume, biography, artists statement about artwork submission(s), exhibition records, or awards/education. (Used for internal purposes only)

_____ **Artwork will not be accepted without hanging wire attached. Hanging wire will be used to secure artwork to hanging system.** Three-dimensional artwork must be ready to exhibit and weight must be specified.

_____ Artists to remit to CAC 15% of the purchase price for any artwork sold through exposure at **ARTventure**. Purchased artwork will be required to remain in the gallery until the conclusion of the event.

_____ I verify that I have personally created all artwork submitted. I agree to indemnify and hold harmless the City of Costa Mesa, Cultural Arts Committee, all City employees and volunteers, Segerstrom Center for the Arts in the event of any damages, theft, loss, and/or damaged artwork in possession during the ARTventure 2019 event. I grant the City of Costa Mesa and CAC the right to use my artwork for promotional purposes. **All artwork is shown at the discretion of the artist.**
