Birthday Party Procedures

Waiver

Applicants must agree to and initial each of the following:

First payment (50%) due at time of reservation. Final payment due on the day of event. No-shows will be billed.

Please make checks payable to the City of Costa Mesa.

Parties are designed for children ages 4 to 10 years.

Reservations must be made at least four weeks in advance. Cancellations or date changes may only be made with at least two weeks notice and are subject to availability. Transfers and cancellations are subject to a \$20.00 fee.

The City of Costa Mesa reserves the right of cancellation in the event of an unforeseen complication, emergency, or act of nature. Cancellation by the City will result in a full refund.

By signing this form, I hereby consent to treatment and all medical care deemed necessary as a result of accident or injury. I further agree to pay any and all costs incurred as a result of said treatment.

Participants in programs are subject to being photographed and such photographs may be used to publicize future city programs, and understand I will not receive any compensation for such use.

I also, agree to waive and release the City of Costa Mesa, its officers, agents, employees and volunteers from and against any and all claims, costs, liabilities, expenses or judgments, including attorney's fees and court costs arising out of my participating in CITY'S PROGRAMS or any illness or injury resulting therefrom, and hereby agree to indemnify and hold harmless CITY from and against any and all such claims, except for illness and injury resulting directly from gross negligence or willful misconduct on the part of CITY or its employees.
