



Group Home House Rules Compliance Certification Form

House Rules provide the backbone and structure for successful operation of a group home that addresses the unique needs of its residents while ensuring that the home is operated in a manner that is compatible with the residential setting desired by its residents. The City of Costa Mesa Municipal Code (CMMC) Section 13-311(a)(1)(3) requires that a copy of the group home rules and regulation be included in the permit application. The purpose of this form is to assist City of Costa Mesa staff in reviewing the Group Home Rules submitted with your application for compliance.

1. Do the Group Homes House Rules stipulate the CMMC requirements referenced below?

Residents Must Actively Participate in a Legitimate Recovery Program – House rules shall include the expectation and requirements for regular meeting attendance and documentation of participation in regular daily or weekly meetings, such as AA/NA/CA or another program that has been deemed effective by the sober living home operator. Minimum attendance rates at these meetings should be established based on a resident’s stage of recovery. Refusal to participate or document regular meeting attendance shall be cause for consequences up to and including eviction. (CMMC Section 13-311(a)(10)(ii))

2. Do the Group Homes House Rules stipulate the CMMC requirements referenced below?

Alcohol and Drug Use – House rules must prohibit the use of any alcohol or any non-prescription drugs at the sober living home or by any individual in recovery, including the house manager if applicable, on or off site. Prescription and Over the Counter Medication – House rules must include a written policy regarding the possession, use, and storage of prescription (continued on next page)

and over the counter medications, that includes monitoring and oversight by qualified staff. The possession or use of prescription medications shall be prohibited except for the person to whom they are prescribed, and in the amount prescribed. Any violation of this rule must be cause for eviction under the sober living home's rules for residency and the violator cannot be re-admitted for at least 90 days. Any second violation of this rule shall result in permanent eviction. Alternatively, the sober living home must have provisions in place to remove the violator from contact with the other residents until the violation is resolved. (CMMC Section 13-311(a)(10)(ii))

Good Neighbor Policy (Sober Living Homes)—the sober living home shall have a good neighbor policy that shall direct occupants to be considerate of neighbors, including refraining from engaging in excessively (continued on next page) loud, profane or obnoxious behavior that would unduly interfere with a neighbor’s use and enjoyment of their dwelling unit. The good neighbor policy shall establish a written protocol for the house manager/operator to follow when a neighbor complaint is received. (CMMC Section 13-311 (a)(10)(vi))
