NOTICE OF PUBLIC HEARING**

**NOTICE IS HEREBY GIVEN** that a public hearing will be held by the Costa Mesa City Council at the regular meeting on **Tuesday, June 21, 2016 at 8:00 P.M.**, or soon thereafter as the matter shall be heard, in the City Hall Council Chambers, 77 Fair Dr., to consider the following item. At this meeting, the City Council will receive public testimony on the General Plan Amendment and the Final Environmental Impact Report (SCH NO. 2015111053).

The 45-day public review period for the Draft EIR was completed on April 18, 2016, and a draft Response to Comments was reviewed by the Planning Commission on April 25, 2016. The Planning Commission held four public hearings and on April 25, 2016 recommended approval of the General Plan and certification of the Environmental Impact Report. The City Council held the first public hearing for this project on May 17, 2016 and is scheduled to hold a third public hearing on June 14, 2016.

**Description:** The 2015-2035 General Plan and Final Environmental Impact Report (FEIR). The project consists of the adoption of updated Land Use, Circulation, Growth Management, Conservation, Noise, Safety, Historic & Cultural Resources, Community Design, and Open Space and Recreation Elements of the City of Costa Mesa General Plan. The General Plan Update will incorporate the Housing Element which was previously adopted in January 2014 and valid through 2021.

Focused amendments are proposed to the Land Use Element. These land use changes affect approximately four percent of the City's land area. The amended Land Use Plan includes, but is not limited to:

- A new land use designation (Multi-Use Center) that applies to the Fairview Development Center site
- Two new land use overlays (Residential Incentive Overlay Zone and Harbor Mixed Use) that apply to key locations along Harbor Boulevard and Newport Boulevard
- Site-specific FAR of 0.64 for the Segerstrom Home Ranch site
- Site-specific density of 80 dwelling units per acre for Sakioka Lot 2
- Amended General Plan designation of Commercial Center and site specific FAR of 0.54 to 0.64 for the former LA Times site

**Public Comments:** Public comments in either oral or written form may be presented during the public hearing. Any written communications, photos, or other material for copying and distribution to the City Council that is 10 pages or fewer must be submitted to the City Clerk **NO LATER THAN 3:00 P.M.** on the day of the hearing, **June 21, 2016** and can also be emailed to [cityclerk@costamesaca.gov](mailto:cityclerk@costamesaca.gov). Please note that records submitted by the public will not be redacted in any way and will be posted online as submitted, including any personal contact information. If the public wishes to submit written communication, photos, or other material for distribution to the City Council at the meeting AFTER 3:00 p.m., 10 copies will need to be provided for distribution. Please note that NO copies of written communication will be made AFTER 3:00 p.m. Any materials to be displayed on the overhead projector at the Council Meeting must be submitted to the City Clerk **NO LATER THAN 15 MINUTES PRIOR TO THE START OF THE MEETING.** If you should need further assistance, please contact the City Clerk's Office at (714) 754-5225.
