

AMENDMENT NUMBER TWO  
TO PROFESSIONAL SERVICES AGREEMENT  
FOR SOLID WASTE COLLECTION SERVICE AT CITY FACILITIES

This Amendment Number Two ("Amendment") is made and entered into this 29<sup>th</sup> day of July, 2016 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation (the "City") and Ware Disposal Inc., a California corporation ("Consultant").

WHEREAS, Consultant and City entered into an agreement on August 1, 2013, for Consultant to provide services relating to solid waste disposal services for solid waste generated at City facilities (the "Agreement"); and

WHEREAS, the City Council authorized the Public Services Director to execute up to five one-year extensions of the Agreement when the City Council approved the Agreement at its meeting held July 2, 2013; and

WHEREAS, the Public Services Director herein exercises his authority to execute the second one-year extension; and

WHEREAS, the parties agree to revise the scope of services to reflect the City's current needs.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged; the Parties agree to amend the Agreement as follows:

1. Section 4.1 of the Agreement is amended to extend the term of one additional year, ending July 31, 2017.


2. The scope of services and compensation for services performed from August 1, 2016 through July 31, 2017, shall be as set forth in Exhibit "A" attached hereto and incorporated herein by this reference.

3. All terms not herein defined shall have the same meaning and use as set forth in the Agreement.

4. All other terms, conditions, and provisions of the Agreement not in conflict with this amendment and previous Amendments, shall remain in full force and effect.
