NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN that a public hearing will be held by the Costa Mesa City Council at the regular meeting on **Tuesday, April 4, 2017 at 7:00 P.M.**, or soon thereafter as the matter shall be heard, in the City Hall Council Chambers, 77 Fair Dr., to request for review of the following:

Description: A retroactive time extension for a Conditional Use Permit to install a 40-foot (long) x 40-foot (wide) helipad/helistop on the roof of an existing industrial building. The helistop will be located on a 6' high platform on the roof of an existing 19' high building. The proposed helipad was approved by the Airport Land Use Commission and by the Federal Aviation Administration. This project was originally approved by the City Council on November 3, 2015. Site Address: 3132 Airway Avenue, Zone MP; Application Number: PA-11-03 (Retroactive Time Extension); Applicant: Kevin Coleman c/o Net Development Company.

Environmental Determination: Categorically exempt under Section 15311, Accessory Structures

Public Comments: Public comments in either oral or written form may be presented during the public hearing. Any written communications, photos, or other material for copying and distribution to the City Council that is 10 pages or less, must be submitted to the City Clerk **NO LATER THAN 3:00 P.M.** on the day of the hearing, **April 4, 2017**.
