

**AMENDMENT NUMBER THREE  
TO PROFESSIONAL SERVICES AGREEMENT  
WITH RODELL R. FICK, ESQ.**

This Amendment is made and entered into this 16<sup>th</sup> day of May, 2017, ("Effective Date") by and between the CITY OF COSTA MESA, municipal corporation ("City") and RODELL R. FICK, ESQ., a sole proprietor ("Consultant").

**WHEREAS**, Consultant and City entered into an agreement on October 1st, 2014, (the "Agreement") for Consultant to preside as the Hearing Officer at Administrative Hearings for Civil Citations; and

**WHEREAS**, the original Agreement contained a provision for an initial term of twelve (12) months with the option to extend the Agreement for up to three (3) term periods of one (1) year each; and

**WHEREAS**, Consultant and City exercised the first and second extension options; and


**WHEREAS**, Consultant and City wish to amend the Agreement to adjust the amount of compensation to Consultant; and

**NOW, THEREFORE**, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. The not to exceed amount referenced in Section 2.1 is amended to Twelve Thousand Dollars and Zero Cents (\$12,000.00).
2. All terms not herein defined shall have the same meaning and use as set forth in the Agreement.
3. All other terms, conditions, and provisions of the successor Agreements not in conflict with this Amendment, shall remain in full force and effect.
