

**AMENDMENT NUMBER FOUR  
TO AGREEMENT  
WITH  
GRP2 UNIFORMS INC. DBA KEYSTONE UNIFORMS OC**

This Amendment Number Four ("Amendment") is made and entered into this 25th day of June, 2018 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and GRP2 UNIFORMS INC., a California corporation DBA KEYSTONE UNIFORMS OC ("Consultant").

WHEREAS, City and Consultant entered into an agreement on June 24, 2016 for the purchase of City staff uniforms (the "Agreement"); and

WHEREAS, Section 4.1 of the Agreement provides for a term of one (1) year, with the option to extend the Agreement for four (4) additional one (1) year periods; and

WHEREAS, on June 24, 2017, City and Consultant extended the term of the Agreement through June 23, 2018 and increased the maximum annual compensation to Thirty-Three Thousand Thirty-Five Dollars (\$33,035.00); and

WHEREAS, on April 23, 2018, City and Consultant extended the term for one (1) year, through June 23, 2019; and

WHEREAS, on June 11, 2018, City and Consultant increased Consultant's maximum annual compensation; and

WHEREAS, City now desires to further increase Consultant's maximum annual compensation.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Section 2.1 of the Agreement shall be amended to reflect that Consultant's annual compensation shall not exceed Forty-Four Thousand One Hundred Forty-Seven Dollars (\$44,147.00).
2. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
3. All other terms, conditions, and provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
