A. Art at the Park (Summer Concerts Series) (Subcommittee's report)

- 1. Overview of Event
 - Lisa informed the Committee that a total of \$480 Sponsorship funds were raised from the selling of Hurley T-Shirts. The Committee spent a total of \$817 (\$277 paint for T-Shirts; \$38 brushes; \$463 crafts and \$39 face paint).
 - The Committee requested the item be added to the January 2011 agenda to start planning for the 2011 series.

B Artist Showcase XIV

- The Committee reviewed the Boathouse venue cost (\$870 for staffing and Security and \$690 for the bartender and ABC license equaling \$1560) to hold the Artist Showcase XIV. The venue only had one date left October 30th. The owner suggested the Committee have food trucks for attendees to purchase food, instead of buying food. The Committee would also need to purchase wine/champagne.
- Since funds are a Committee concern, Frank discussed a phase II of the Artist Showcase: Integrate the Artists who have participated in the Artist Showcase into a "Day of Art" by partnering with the local galleries. The Committee would find out each of Hurley's 1st opening dates, contact the galleries (World Gallery; Mesa Art; Fine Framing; Whittier Law School; Wyndham; Showcase Gallery and the LAB's Artery) do a Call for Artists; give each gallery a CD of potential participating artists; the galleries choose the artist and directly work with them; the Galleries handle all gallery aspects of the event and the Committee handles advisement. The Galleries would donate a small percentage (10%-15%) of Committee Artist art sold back to the Committee.
- Frank will speak to Hurley about the partnering idea and find out when their next opening will be.
- Tony made a motion to postpone the October Showcase until funds are available and established a partnership with Hurley; World Gallery and Mesa Art.; seconded by Craig; unanimously approved.

C. Sponsorship (Subcommittee report)

- Jessica will work on a new Sponsorship pamphlet layout
- The Committee will research other printing company prices and possible in-kind sponsorships.
- Jessica will speak to the Newport Beach Art Commission on how they obtain sponsorships and disturbed scholarships
