### CODE AMENDMENT CO-18-05 TO CODIFY AND AMEND CHAPTER VIII OF TITLE 13 OF THE COSTA MESA MUNICIPAL CODE (PLANNING, ZONING AND DEVELOPMENT), REMOVING TIME PERIODS FOR DISPLAY OF NON-COMMERCIAL PORTABLE SIGNS ON PRIVATE RESIDENTIALLY-ZONED PROPERTIES

The Costa Mesa Planning Commission will hold a public hearing to consider Code Amendment CO-18-05 to amend portions of Title 13 of the Costa Mesa Municipal Code (Zoning Regulations) to remove Code provisions that restrict the time periods that non-commercial portable signs on private residentially-zoned properties are allowed to be displayed.

**Environmental Determination:** The ordinance is exempt from the provisions of the California Environmental Quality Act (CEQA) under Section 15061(b)(3) (General Rule).
