

**AMENDMENT NUMBER THREE  
TO PROFESSIONAL SERVICES AGREEMENT  
WITH  
ALLIED NATIONWIDE SECURITY, INC.**

This Amendment Number Three ("Amendment") is made and entered into this 15th day of January, 2019 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and ALLIED NATIONWIDE SECURITY, INC., a California corporation ("Consultant").

WHEREAS, City and Consultant entered into a Professional Services Agreement on June 10, 2014 for Consultant to provide one unarmed security officer at the Costa Mesa Senior Center, Monday through Friday, from 7:30 a.m. to 4:00 p.m. (the "Agreement"); and

WHEREAS, on October 15, 2015, City and Consultant amended the scope of services and increased Consultant's maximum annual compensation; and

WHEREAS, on June 9, 2017, City and Consultant extended the term of the Agreement through June 9, 2019, clarified the scope of services, and increased Consultant's maximum annual compensation; and

WHEREAS, City and Consultant now desire to amend the Scope of Services to include the additional services set forth in Exhibit "A," attached hereto and incorporated herein by this reference, and to extend the term of the Agreement through June 30, 2019; and

WHEREAS, City desires to increase Consultant's maximum annual compensation accordingly to One Hundred Thirty-Three Thousand Two Hundred Dollars (\$133,200.00).

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The term of the Agreement shall be extended through June 30, 2019.
2. The Scope of Services shall be amended to include the additional services set forth in Exhibit A.
3. Section 2.1 of the Agreement shall be amended to reflect that Consultant's annual compensation shall not exceed One Hundred Thirty-Three Thousand Two Hundred Dollars (\$133,200.00). Consultant shall be paid according to the fee schedule set forth in the Agreement and Exhibit A of this Amendment.
4. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
5. All other terms, conditions, and provisions of the Agreement, as amended, not in conflict with this Amendment shall remain in full force and effect.



## EXHIBIT A

### ADDITIONAL SERVICES

#### A. Security Services at Costa Mesa Senior Center during Public Meetings

Allied Nationwide Security shall provide the services of one unarmed security officer at the Costa Mesa Senior Center on public meeting dates from 4:00 p.m. to 8:00 p.m., unless otherwise agreed to in writing by the parties. City will provide Allied Nationwide Security with a schedule of public meeting dates.

**Type of service:** patrol the facility; deter illegal activities; file Daily Activity Report (DAR)

**Hourly rate:** \$19.95/hour

Allied shall not charge overtime to City, unless required to provide services on New Year's Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, or Christmas Day.

#### B. Security Services at Lions Park

Commencing February 12, 2019, or on such other date as agreed to in writing by the parties, Allied Nationwide Security shall provide the services of one unarmed security officer at Lions Park, located at 570 W. 18th St., Costa Mesa. Allied Nationwide Security shall provide such services 24 hours per day, 7 days per week.

**Type of service:** patrol the facility; deter illegal activities; file Daily Activity Report (DAR)

**Hourly rate:** \$19.95/hour

**Rate for use of personal transportation vehicle/device, such as golf cart or Segway:**  
\$300/month

Allied shall not charge overtime to City, unless required to provide services on New Year's Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, or Christmas Day.
