

**AMENDMENT NUMBER TWO
TO PROFESSIONAL SERVICES AGREEMENT
WITH
JOHNSON FAVARO**

This Amendment Number Two ("Amendment") is made and entered into this 15th day of January, 2019 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and JOHNSON FAVARO, a California limited liability partnership ("Consultant").

WHEREAS, City and Consultant entered into an agreement on December 1, 2015 for Consultant to provide architectural services in connection with the construction of a new library and community center (the "Agreement"); and

WHEREAS, on July 30, 2018, City and Consultant amended the Scope of Services and increased Consultant's maximum compensation accordingly; and

WHEREAS, City and Consultant now desire to amend the Scope of Services to include the additional services set forth in Exhibit "A", attached hereto and incorporated herein by this reference; and

WHEREAS, City desires to increase Consultant's maximum compensation accordingly to Three Million Seven Thousand One Hundred Fifty-Three Dollars (\$3,007,153.00).

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The Scope of Services shall be amended to include the additional services set forth in Exhibit A.
2. Section 2.1 of the Agreement shall be amended to reflect that Consultant's total compensation shall not exceed Three Million Seven Thousand One Hundred Fifty-Three Dollars (\$3,007,153.00).
3. Consultant shall be paid a lump sum for the additional services as set forth in Exhibit A.
4. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
5. All other terms, conditions, and provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.


