

**AMENDMENT NUMBER ONE  
TO PROFESSIONAL SERVICES AGREEMENT  
WITH  
GRANICUS, INC.**

This Amendment Number One ("Amendment") is made and entered into this 27th day of February, 2019 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and GRANICUS, INC., a California corporation ("Consultant").

WHEREAS, City and Vision Technology Solutions, LLC ("Vision") entered into an agreement on February 15, 2017 for Vision to provide website development and content management services (the "Agreement"); and

WHEREAS, Consultant acquired Vision as of February 9, 2018; and

WHEREAS, as permitted by Section 1.7 of the Agreement, Vision assigned the Agreement to Consultant as part of the acquisition; and

WHEREAS, City and Consultant desire to amend the Agreement to reflect the assignment.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Consultant agrees to assume all of Vision Technology Solutions, LLC's duties and obligations set forth in the Agreement.
2. Any and all references in the Agreement to "Vision Technology Solutions, LLC" shall be amended to read, "Granicus, Inc."
3. Section 6.4 of the Agreement shall be amended to set forth Consultant's contact information as follows:
