Individuals Assisted	66	Street Outreach: Provided 49 Resident clients, 14 Non-Resident clients and 3 unknown clients' services and assistance.
Contacts	69	Street Outreach: Made 69 contacts with various clients.
Housing	3	Street Outreach: Outreach assisted in housing 2 resident clients and was informed by 1 resident client that they have been housed through an independent source.
Temporary Housing	1	Street Outreach: Outreach was informed by resident client that they are temporarily living with a family member.
Emergency Housing	1	Street Outreach: Outreach was informed that resident client has been housed on an emergency basis through an independent source.
Reconnection	0	Street Outreach: no reconnections were performed by Outreach.
Bridge Shelter Placement	13	Street Outreach: 13 resident clients placed at the CM Bridge Shelter.
Linkage Type	Outreach	Updates
<u>Collaborative Case Management</u>	36	Street Outreach: Provided 36 linkages to collaborative case management services such as housing support services with case manager, medical linkages with hospital social worker, or mental health supportive services with mental health specialist.
<u>Housing Assessments</u>	2	Street Outreach: Administered 2 housing assessments on resident clients to assess their eligibility for government-subsidized housing.

<u>Documentation</u>	10	Street Outreach: Offered resident and non-resident clients several documentation services such as assisting with completing and sending disabling condition forms, provision of identification card vouchers, consent forms, and provided homeless verification forms.
<u>Housing/Recovery Assistance</u>	13	Street Outreach: Provided resident clients with housing listings for affordable rooms and apartments in their area.
<u>Job Connection</u>	0	Street Outreach: Outreach did not provide any linkages to employment resources.
<u>Legal Services</u>	2	Street Outreach: Outreach linked 2 resident clients to legal resources this week.
<u>Medical</u>	3	Street Outreach: Outreach reminded resident client about an upcoming medical assessment. Outreach will follow up with client to check on their condition.
<u>Mental Health</u>	1	Street Outreach: Outreach linked disabled, non-resident client to local mental health clinic for services.
<u>Other</u>	4	Street Outreach: Outreach provided social support for hospitalized resident client.
<u>Rental Resources</u>	0	Street Outreach: No linkages to rental resources provided this week.
<u>Social Services</u>	1	Street Outreach: Outreach contacted local Child Protective Services to report an incident regarding a possible abuse related to a homeless family. Child Protective Services will follow up and work with family in investigating this case.
<u>Substance Abuse</u>	1	Street Outreach: Outreach provided resident client with a resource listing of various drug treatment facilities in the area that accept client's insurance.
<u>Transportation</u>	20	Street Outreach: Provided Bus Passes, Cab Rides and other transportation services to support clients' transportation needs.
