| <u>Medical</u> | 16 | Bridge Shelter: Shelter guest disclosed to Inreach worker about a medical related issue that needed immediate medical attention, Inreach ordered for an ambulance to take guest to local emergency room. |
| <u>Mental Health</u> | 31 | Bridge Shelter: Inreach worker linked shelter guest to partner agency for mental health services. |
| <u>Other</u> | 12 | Bridge Shelter: Inreach assisted shelter guest in opening a bank account to assist in managing finances. |
| <u>Rental Resources</u> | 2 | Bridge Shelter: Shelter guest was linked to community housing partner for possible rental assistance services. |
| <u>Social Services</u> | 20 | Bridge Shelter: Inreach linked shelter guest to community partner agency for assistance in appealing her Social Security benefits. |
| <u>Substance Abuse</u> | 5 | Bridge Shelter: Inreach provided shelter guest with resources on various for drug treatment and rehabilitation that accepted guest's medical insurance. |
| <u>Transportation</u> | 30 | Bridge Shelter: Provided Bus Passes, Cab Rides, and other transportation services to support shelter guests' transportation needs. |
