Temporary Housing	2	Street Outreach: Outreach did not provide any linkages to temporary housing this week.

Reconnection	0	Street Outreach: Outreach in collaboration with community partner reconnected 2 non-resident clients to an out of state location for housing purposes.

<u>Collaborative Case Management</u>	34	Street Outreach: Provided 34 linkages to collaborative case management services such as housing support services with case manager, medical linkages with hospital social worker, or mental health supportive services with mental health specialist.

<u>Housing Assessments</u>	0	Street Outreach: Outreach did not administer any housing assessments on resident clients to assess their eligibility for government-subsidized housing.
<u>Documentation</u>	19	Street Outreach: Offered resident and non-resident clients several documentation services such as assisting with completing and sending disabling condition forms, provision of identification card vouchers, consent forms, and provided homeless verification forms.
<u>Housing/Recovery Assistance</u>	20	Street Outreach: Provided resident clients with housing listings for affordable rooms and apartments in their area.
<u>Job Connection</u>	1	Street Outreach: Outreach linked resident client to employment resources
<u>Legal Services</u>	5	Street Outreach: Outreach linked 5 resident clients to legal services to assist with legal matters.
<u>Medical</u>	7	Street Outreach: Outreach linked resident client to local medical for healthcare services.
<u>Mental Health</u>	7	Street Outreach: Outreach linked resident client to local clinic for mental health services to support client with ongoing symptoms related to their mental disorder.

<u>Rental Resources</u>	2	Street Outreach: Outreach linked resident client to community agency for rental assistance.
<u>Social Services</u>	4	Street Outreach: Outreach assisted resident client in reinstating their county benefits.
