SUBJECT: GAIP RFP Approval

Dear Chair Bartlett and Members of the Board,

I am writing in regards to the Board of Supervisor's meeting on Tuesday, September 10, 2019, at which time you will consider the issuance of a Request for Proposals (RFP) for John Wayne Airport's General Aviation Improvement Program. In this process, I urge you to ensure the following:

- For full transparency, make the RFP scores and proposals available to the public
- Include specific numbers and percentages of General Aviation aircrafts to maintain the existing mix of General Aviation aircraft size and type in terms of wingspan
- Include a community representative on the RFP review panel
- Limit the hours of operation of the General Aviation terminal to match those of the commercial terminals
- Guarantee provisions for future aircraft utilizing electric or alternative energy

Additionally, I request that you consider the development and implementation of a curfew and noise violation fee program and to use the proceeds to create and fund a grant program to financially assist affected residences in performing noise and air quality improvements.

Thank you for the opportunity to review the proposed RFPs. The City of Costa Mesa appreciates the opportunity to participate with the County to address concerns of impacted local residents and to limit impacts to the greatest extent practical.
