

Commercial Collection

Waste Management will provide bin services for commercial and multi-family properties for the collection of trash, recyclables and food waste. Commercial services are available using bins that range in size from 1.5 cubic yards to 8 cubic yards that can be serviced up to six days per week. Locked bins are available. Push-out service can also be provided for an additional charge. Larger roll-off bins may be available upon request.

What Goes in Your Bin?

Trash

- Carpet, Drywall, Soil Contaminated Paper & Plastics, Waxy Cardboard/Paper/Produce Boxes

Green Waste

- Yard trimmings (No palm fronds, soil, rocks, manure or animal waste)

Recycle

- Paper/Cardboard, Plastics, Metal, Glass

Food Waste

- Meat, Fish & Poultry, Eggshells, Seashells & Bones, Fats, Oils & Greases, Cheese & Dairy Products, Fruits & Vegetables, Bread, Pasta, Rice & Grains, Coffee Grounds, Filters & Tea Bags, Food Soiled Paper, Flowers



Commercial Recycling

Waste Management provides commercial customers and multi-family complexes assistance in meeting state recycling requirements. The following is a summary of legislation that may impact your business:

MANDATORY COMMERCIAL RECYCLING (AB 341):

The Mandatory Commercial Recycling Law (AB 341) requires commercial businesses to subscribe to recycling in California. This legislation was effective July 1, 2012, and is designed to help meet California's recycling goal of 75% by the year 2020. This law requires California commercial businesses and public entities that generate four or more cubic yards per week of waste and multi-family housing complexes with five or more units, to adopt recycling practices. COMMERCIAL ORGANICS RECYCLING LAW AB 1826:

Assembly Bill (AB) 1826 establishes that restaurants, grocery stores, and other commercial food and yard waste producers generating at least 4 cubic yards of organics per week, are required to separate their organics and properly send the materials to an organics processing facility. Services

CONSTRUCTION AND DEMOLITION SERVICES:

Waste Management can tailor recycling programs to meet the needs of local developers and do-it-yourself projects. Roll-off bins can be utilized for trash or recycling services, such as for construction and demolition (C&D) projects, construction debris or other dumpster services.

ROLL-OFF SERVICES:

Commercial or industrial customers have the option to utilize roll-off services. Waste Management provides 10 cubic yard to 50 cubic yard bins, as well as specialized compactors. Roll-off bins can be utilized for trash or recycling services, such as for construction and demolition (C&D) projects. Commercial recycling services are also provided through the collection of 96-gallon carts, for businesses that generate a low volume of recyclable materials. SPECIAL SERVICES:

Waste Management offers a Scout or Push-Out Service for those businesses where a commercial trash truck may not be capable of accessing your location. These are smaller vehicles that can easily access your property. Waste Management staff will determine if such a service is necessary and arrange to provide this service to your business at no additional charge.

BULB, BATTERY & UNIVERSAL WASTE RECYCLING

Waste Management's Lamtrackr program provides mail-back kits to help you properly recycle CFL bulbs and other universal waste materials such as batteries and ballasts.

BULKY ITEM SERVICE:

Collection of large household items, appliances, furniture or multiple smaller items is available for Costa Mesa multi-family customers twice a year at no charge (up to two items per pickup). Acceptable items include: furniture, mattresses, appliances, lumber (cut into 4-foot pieces and bundled), oversized household solid waste, refrigerators and air conditioners. Unacceptable Materials include: Hazardous substances and Household Hazardous Waste, such as waste oil, antifreeze and electronic waste (E-waste). Please call Waste Management at least 24 hours in advance of your regular collection day.



TEMPORARY BIN SERVICE:

No matter what the project size, we have a variety of service options available. For smaller jobs, you may order an Insta-bin, a temporary collection bin that is 3 cubic yards, or purchase a Bagster. The Bagster is approximately the same size as the Insta-bin, but it is capable of holding a greater weight. For larger jobs, Waste Management offers temporary roll-off containers, which range in size from 10 cubic yards to 40 cubic yards.
