Permit is for residential lightweight roofing only (under 600 lbs per 100 square foot). Any material that is over 600 lbs per 100 square foot will require structural calculations to be submitted.

Waste hauling requirements are exempt for tear off of asphalt roofing products. Tear off of wood shake, tile, metal, and all other materials aside from asphalt will be required to abide by the waste hauling requirements in place that conform with the State of California requirements.

Permits that are over \$10,000 in valuation will require a Construction Access permit from the Public Works Division.
