

**AMENDMENT NUMBER ONE TO
PROFESSIONAL SERVICES AGREEMENT
WITH
LINSCOTT, LAW, GREENSPAN & ENGINEERS**

This Amendment Number One (“Amendment”) is dated January 11, 2024, (“Effective Date”), by and between the CITY OF COSTA MESA, a municipal corporation (“City”) and LG2WB ENGINEERS, Inc., dba LINSCOTT, LAW, & GREENSPAN ENGINEERS (“Consultant”).

WHEREAS, City and Consultant entered into an agreement on January 11, 2024 to utilize the services of Consultant as an independent contractor to provide professional engineering design services for the development and construction bid documents of the City’s Del Mar Avenue Bicycle Facility Project, (the “Agreement”); and

WHEREAS, Section 2.1 of the Agreement provides for compensation at an amount not-to-exceed Forty-Three Thousand Thirteen Dollars and Thirty Cents (\$43,013.30); and

WHEREAS, the parties now desire Consultant to provide additional engineering related services, which requires an increase in compensation by ten thousand three hundred dollars (\$10,300), which would bring the not-to-exceed amount of the Agreement to fifty-three thousand three hundred thirteen dollars and thirty cents (\$53,313.30).

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The second sentence in section 2.1 of the Agreement is revised to state, “Consultant’s total compensation shall not exceed fifty-three thousand three hundred thirteen dollars and thirty cents (\$53,313.30).”
2. Exhibit “C” to this Amendment replaces the Exhibit “C” of the original Agreement.
3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
4. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.


