

**AMENDMENT NUMBER FOUR TO  
PROFESSIONAL SERVICES AGREEMENT  
WITH  
NATIONAL DATA AND SURVEYING SERVICES, INC.**

This Amendment Number Four ("Amendment") is dated the 25th day of April, 2024 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City") and NATIONAL DATA AND SURVEYING SERVICES, INC., a California corporation ("Consultant").

WHEREAS, City and Consultant entered into an agreement on April 29, 2021, for Consultant to provide traffic data collection services on an as-needed basis (the "Agreement"); and

WHEREAS, City and Consultant entered into Amendment One to the Agreement on April 14, 2022 to increase Consultant's maximum compensation to an amount not to exceed Fifteen Thousand Dollars (\$15,000) and extend the term of the Agreement to end on April 28, 2024; and

WHEREAS, City and Consultant entered into Amendment Two to the Agreement on November 9, 2022 to increase Consultant's maximum compensation to an amount not to exceed Twenty-Five Thousand Dollars (\$25,000); and

WHEREAS, City and Consultant entered into Amendment Three to the Agreement on March 11, 2024 to extend term of the Agreement until April 20, 2025; and

WHEREAS, City and Consultant desire to amend Section 2.1 of the Agreement to reflect an annual compensation amount.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to amend the Agreement as follows:


1. **Compensation.** Section 2.1 of the Agreement is revised to state:

"2.1. **Compensation.** Consultant shall be paid in accordance with the fee schedule set forth in Exhibit "B," attached hereto and made a part of this Agreement by this reference (the "Fee Schedule"). Consultant's total annual compensation shall not exceed Twenty-Five Thousand Dollars (\$25,000)."

2. **Same Meaning.** All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
3. **Counterparts.** This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
