

**AMENDMENT NUMBER ONE TO  
PROFESSIONAL SERVICES AGREEMENT  
WITH  
ALL-CITY MANAGEMENT SERVICES, INC.**

This Amendment Number One ("Amendment") is dated August 1, 2024, ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City") and ALL-CITY MANAGEMENT SERVICES, INC. a California corporation ("Contractor").

WHEREAS, City and Contractor entered into an agreement on August 1, 2023 for Contractor to provide school crossing guard services; and

WHEREAS, Section 2.1 of the Agreement provides that Contractor's total compensation shall not exceed \$328,569.00 annually; and

WHEREAS, Section 2.1 of the Agreement allows Contractor to request at least thirty (30) days prior to the expiration of the initial term, a price increase based on an increase in the Consumer Price Index for all Urban Consumers in the Los Angeles-Long Beach-Anaheim area (CPI) determined upon the June index of the present year and the June index of the preceding year; and

WHEREAS, City and Contractor now desire to approve the CPI rate adjustment; and

WHEREAS, City and Contractor intend and desire that this Amendment Number One be retroactive to the Effective Date.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. This Amendment One shall be retroactive to the Effective Date.
2. This Amendment One to the Agreement provides that commencing on the Effective Date, Contractor shall be authorized to raise its rate pursuant to the CPI (3.2%) in the amount of \$6,026.65 annually, for a total annual compensation not to exceed \$334,595.65.
3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
4. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.


