

**AMENDMENT NUMBER SIX TO
PROFESSIONAL SERVICES AGREEMENT
WITH
LYONS SECURITY SERVICE, INC.**

This Amendment Number Six ("Amendment") is dated August 30, 2024, ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City") and LYONS SECURITY SERVICE, INC. a California corporation ("Consultant").

WHEREAS, City and Consultant entered into an agreement on July 1, 2019 for Consultant to provide security services (the "Agreement"); and

WHEREAS, Section 4.1 of the Agreement provides for a term of two (2) years, with the option to extend the Agreement for three (3) additional one (1) year periods; and

WHEREAS, City and Consultant entered into five prior amendments such that the Agreement, as revised, is set to expire on August 30, 2024;

WHEREAS, to allow the City additional time to complete its current RFP selection process, the parties desire to extend the term of the agreement for an additional two months;

WHEREAS, the parties do not intend to change the current not-to-exceed amount of \$579,362.72;

WHEREAS, there are no monetary increases that exceed the annual value of the prior years of the contract, and

WHEREAS, City staff has determined the extension to be in the best interest of City.


NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The term of the Agreement shall be extended through October 31, 2024.
2. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
3. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
4. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.


