

**AMENDMENT NUMBER TWO TO
PROFESSIONAL SERVICES AGREEMENT
WITH
ROSELL SURVEYING & MAPPING, INC.**

This Amendment Number Two (“Amendment”) is dated October 5, 2024, (“Effective Date”), by and between the CITY OF COSTA MESA, a municipal corporation (“City”) and ROSELL SURVEYING & MAPPING, INC. a California Corporation (“Contractor”).

WHEREAS, City and Contractor entered into an agreement on October 5, 2022 for the provision of on call land surveying services; and

WHEREAS, City and Contractor entered into Amendment One on May 23, 2023, to increase Contractor’s annual compensation to a not to exceed amount of Forty Nine Thousand Five Hundred Dollars (\$49,500.00); and

WHEREAS, Section 4.1 of the Agreement provides for a two (2) year term and City desires to extend the Agreement one additional year; and

WHEREAS, City and Contractor now desire to extend the Agreement through October 4, 2025; and


WHEREAS, City and Contractor intend and desire that this Amendment Number Two be retroactive to the Effective Date.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The foregoing recitals in the Agreement are hereby declared to be true and correct and are incorporated as if fully set forth herein.
2. This Amendment shall be retroactive to the Effective Date.
3. Section 4.1 of the Agreement shall be amended to provide that the term of the Agreement is extended through October 4, 2025.
4. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
5. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
6. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
