

**AMENDMENT NUMBER ONE TO  
MAINTENANCE SERVICES AGREEMENT  
WITH  
SUPERIOR PAVEMENT MARKINGS, INC.**

This Amendment Number One ("Amendment") is dated December 7, 2024, ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City") and SUPERIOR PAVEMENT MARKINGS, INC. a California corporation ("Contractor").

WHEREAS, City and Contractor entered into a Maintenance Services Agreement on December 7, 2021 for Contractor as an independent contractor to provide street striping and thermoplastic marking services; and

WHEREAS, Section 4.1 of the Agreement provides that term of the Agreement will continue for three (3) years and end on December 6, 2024 with the option to extend the Agreement by two (2) additional one (1) year periods upon mutual written agreement of both parties; and

WHEREAS, City and Contractor now desire to exercise the first option to extend the Agreement for an additional one (1) year through December 6, 2025; and

WHEREAS, City and Contractor intend and desire that this Amendment Number One be retroactive to the Effective Date.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. This Amendment shall be retroactive to the Effective Date.
2. The term of the Agreement is extended one (1) year ending on December 6, 2025.
3. Compensation shall remain the same.
4. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
5. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
6. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
