

**AMENDMENT NUMBER ONE TO  
PROFESSIONAL SERVICES AGREEMENT  
WITH  
CITYGATE ASSOCIATES, LLC DBA CITYGATE FIRE & EMT**

This Amendment Number One ("Amendment") is dated December 19, 2024, ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City") and CITYGATE ASSOCIATES, LLC DBA CITYGATE FIRE & EMT, a California limited liability company ("Consultant").

WHEREAS, City and Consultant entered into an agreement on December 22, 2023 for Consultant as an independent contractor to perform a Fire Department Standards of Coverage assessment; and

WHEREAS, Section 4.1 of the Agreement provides that the term of the Agreement shall end on December 31, 2024, and that the Agreement may be extended by two (2) additional one (1) year periods upon mutual written agreement of both parties; and

WHEREAS, City and Consultant now desire to extend the Agreement one additional year; and

WHEREAS, City and Consultant intend and desire that this Amendment Number One be retroactive to the Effective Date.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The foregoing recitals are hereby declared to be true and correct and are incorporated as if fully set forth herein.
2. This Amendment shall be retroactive to the Effective Date.
3. This term of the Agreement is extended one year ending on December 31, 2025.
4. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
5. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
6. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
