

**AMENDMENT NUMBER FOUR TO
PROFESSIONAL SERVICES AGREEMENT
WITH
LG2WB ENGINEERS, INC. DBA LINSOTT LAW, GREENSPAN & ENGINEERS**

This Amendment Number Four ("Amendment") is dated November 30th, 2024, ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City") and LG2WB ENGINEERS, Inc., dba LINSOTT LAW, & GREENSPAN ENGINEERS ("Consultant").

WHEREAS, City and Consultant entered into an agreement on December 1, 2020 for Consultant to provide traffic management and signal system support services (the "Agreement"); and

WHEREAS, City and Consultant entered into Amendment One to the Agreement on October 6, 2021, to increase Consultant's compensation to \$25,000.00; and

WHEREAS, City and Consultant entered into Amendment Two to the Agreement on December 1, 2022, to extend the term of the Agreement through November 30, 2023; and

WHEREAS, City and Consultant entered into Amendment Three to the Agreement on February 27, 2024, to extend the term of the Agreement through November 30, 2024; and

WHEREAS, Section 4.1 of the Agreement provides for a term of two (2) years, with the option to extend the Agreement for two (2) additional one (1) year periods; and

WHEREAS, City and Consultant desire to extend the term for one (1) year, from November 30, 2024 through November 30, 2025; and

WHEREAS, City and Consultant desire that this Amendment be effective retroactive to the Effective Date.


NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The foregoing recitals in this Amendment are hereby declared to be true and correct and are incorporated as if fully set forth herein.
2. This Amendment shall be effective retroactive to the Effective Date.
3. The term of the Agreement shall be extended through November 30, 2025.
4. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.

5. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
6. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.




