

**AMENDMENT NUMBER ONE TO
PROFESSIONAL SERVICES AGREEMENT
WITH
NANCY K BOHL, INC. dba
THE COUNSELING TEAM INTERNATIONAL**

This Amendment Number One (“Amendment”) is dated April 12, 2024, (“Effective Date”), by and between the CITY OF COSTA MESA, a municipal corporation (“City”) and NANCY K BOHL, INC. dba THE COUNSELING TEAM INTERNATIONAL, a California corporation (“Consultant”).

WHEREAS, City and Consultant entered into an agreement on April 12, 2023 for Consultant as an independent contractor to provide First Responder Wellness Services; and

WHEREAS, Section 4.1 of the Agreement provides for a twelve (12) month term, ending on April 11, 2024, which may be extended by three (3) additional one (1) year periods upon mutual written agreement of the parties; and

WHEREAS, City and Consultant now desire to exercise the first of three options to extend the Agreement one (1) more year to April 11, 2025; and


WHEREAS, City and Consultant intend and desire that this Amendment Number One be retroactive to the Effective Date.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The foregoing recitals in this Agreement are hereby declared to be true and correct and are incorporated as if fully set forth herein.
2. This Amendment shall be retroactive to the Effective Date.
3. Section 4.1 of the Agreement is amended to extend the Agreement one (1) year to April 11, 2025.
4. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
5. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
6. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.




