NOTICE IS HEREBY GIVEN that a public hearing will be held by the Costa Mesa City Council at its regular meeting at City Hall Council Chambers, 77 Fair Drive, Costa Mesa, California on **Tuesday, December 2, 2025, at 7:00 P.M.**, or as soon as possible thereafter, to consider:

Applicant/Agent/Appellant: The Ohio House, LLC, George Castaneda, Diego Blake, Garey Miller, Kayl McReynolds, and Robert Palmer

Site Address: 115 East Wilson Street, Units A through E

Zone: R2-MD – Multiple-Family Residential Medium Density

Description: An appeal of the Planning Commission's decision to uphold the Economic and Development Services Director's decision to deny a Reasonable Accommodation Request to deviate from certain requirements of the zoning code to operate a sober living home. On September 22, 2025, the Planning Commission upheld the Economic and Development Services Director's (July 2, 2025) denial of the Reasonable Accommodation request and adopted a resolution to uphold the Director's denial on a 5-1 vote, with one member absent.

Environmental Determination: The project is exempt from the provisions of the California Environmental Quality Act (CEQA) per CEQA Guidelines Section 15301 (Class 1), Existing Facilities.

The video must be one of the following formats, .mp4, .mov or .wmv. Only one file may be included per speaker for public comments. Please note that materials submitted by the public that are deemed appropriate for general audiences will not be redacted in any way and will be posted online as submitted, including any personal contact information.
